THE APPLICATION OF EL PASO NATURAL GAS COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS SAN JUAN 28-6 UNIT WELL NO. 82, LOCATED 1650 FEET FROM THE NORTH LINE AND 1800 PEET FROM THE BAST LINE OF SECTION 13, TOWNSHIP 27 NORTH, RANGE 6 WEST, MIPH, RIO ARRIBA COUNTY, NEW MEXICO, IN SUCH A MANNER AS TO PERMIT THE PRODUCTION OF GAS FROM THE BLANCO MERAVEROR POOL, AND THE PRODUCTION OF GAS FROM THE PICTURED CLIFFS PORMATION ADJACENT TO THE SOUTH BLANCO PICTURED CLIFFS POOL.

OF THE OIL CONSERVATION CONSISSION

Under the previsions of Rule 112-A (c) El Paso Natural Cas Company, made application to the New Mexico Cil Conservation Commission on July 21, 1958, for permission to dually complete its San Juan 28-6 Unit Well No. 82, located 1650 feet from the North line and 1800 feet from the East line of Section 13, Township 27 North, Range 6 West, MMPM, Rie Arriba County, New Mexico, in such a manner as to permit the production of gas from the Blanco Messwerde Poel and the production of gas from the Pictured Cliffs formation adjacent to the South Blanco Pictured Cliffs Foel.

Now, on this 30th day of July, 1958, the Secretary-Director finds:

- (1) That application has been duly filed under the previsions of Subsection 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the preposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED!

That the applicant herein, El Paso Natural Gas Company, be and the same is hereby authorised to dually complete its San Juan 28-6 Unit Well No. 82, located 1650 feet from the North line and 1800 feet from the East line of Section 13, Township 27 North, Range 6 West, NMPM, Rie Arriba County, New Mexice, in such a manner as to permit the production of gas from the Blanco Mesaverde Peol and the production of gas from the Pictured Cliffs formation adjacent to the South Blanco Pictured Cliffs Peol, through the casing-tubing annulus and the tubing respectively.

PROVIDED HOWEVER. That applicant shall complete, operate, and produce said well in accordance with the previsions of Section V, Rule 112-A, as amended by Order R-1214.

PROVIDED FURTHER. That the operator shall make any and all tests, including segregation and packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the Blance Mesagarde Peel, commencing in the year 1959, and whenever the packer is disturbed, but not excluding any other tests and/or determinations as desmed necessary by the Commission.

IT IS FURTHER ORDERED. That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights;

upon failure of applicant to comply with any requirement of this order after proper notice and hearing the Commission may terminate the authority hereby granted and require applicant or its successors and assigns to limit its activities to regular single-some production in the interests of conservation.
