Gas circulation will be used thru the Mesa Verde & a production liner will be set. Possible productive intervals will be perforated & fractured. Estimated Total Depth 5633'.

10 3/4" at 170' with 150 sacks cement circulated to the surface.

7 5/8" at 3423 with 250 sacks cement.

5 1/2" liner at 5633' with 300 sacks cement.

The W/2 of Section 12 is dedicated to the Mesa Verde.

The SW/4 of Section 12 is dedicated to the Pictured Cliffs.

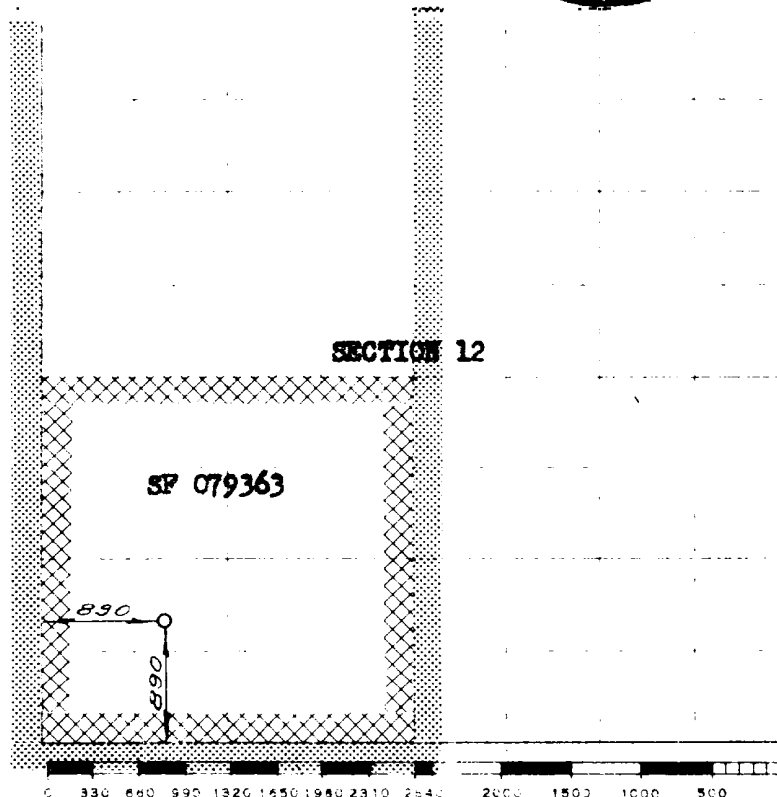
