DETAILS OF WORK

It is intended to ~~and~~ drill a well with rotary tools to 7907', and set a combination 4 1/2" x 5 1/2" production string. All possible Mesa Verde & Dakota producing zones will be perforated and fractured. The well will then be dually completed.

Casing Program:

9 5/8" @ 280' with 200 sacks cement circulated to surface.
5 1/2" @ 7907' with 2 and 3 stage collars. 2nd stage collar 50' below base of Point Lookout, 3rd stage collar 100' below base of Pictured Cliffs.
Cement 1st stage w/120 sacks to cover 100' above Greenhorn. 2nd stage w/190 sacks to cover 100' above Cliff House, 3rd stage w/150 sacks to cover Ojo Alamo.

The E/2 of Section 8 is dedicated to this well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

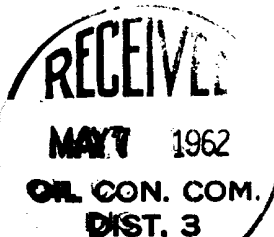
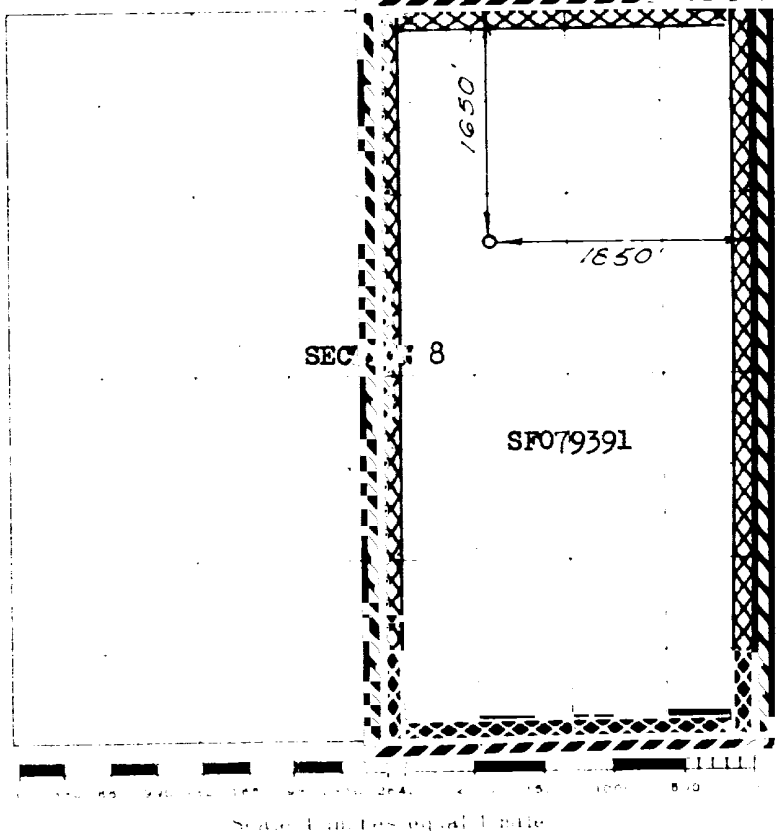
