After setting 7" casing at 5270' and drilling ahead with gas to a depth of 5280' the well became wet.

On 12-23-54 Total Depth 5300'.  
 The interval 5270' - 5300' was squeezed with 125 sacks of D.O.C. Breakdown pressure 800#, Maximum pressure 1800#, Maximum standing pressure 1500#. Upon drilling out the formation was found to be dry.
