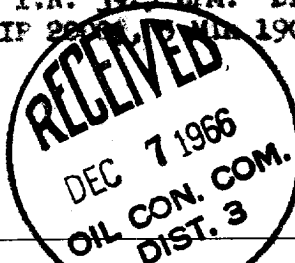

11-10-66 T. D. 8433'. Ran 257 joints 5 1/2", 17# & 15.5# J-55 casing (8419') set at 8432' w/295 sacks cement. W.O.C. 12 hours. Tested w/1500#/30 Min. O. K.

11-13-66 T.D. 8749'. Ran 13 joints 4", 11.6#, J-55 liner (420') set from 8329' to 8749' w/100 sacks cement. W.O.C. 18 hours. Tested w/1500#/30 Min. O. K.

11-18-66 Spotted 250 gallons 7 1/2% MCA. Perf. Dakota 8487-91, 8504-88, 8594-8602, 8642-64' w/16SPZ. Frac w/46,000# 40/60 sand, 46,250 gallons water. Max. pr. 3800#, PPF 2200#, tr. pr. 3200-3500-3800#. I.R. 39.5 BPM. Dropped 3 sets of 16 balls, flushed w/8980 gallons of water. ISIP 2000# w/1900#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
