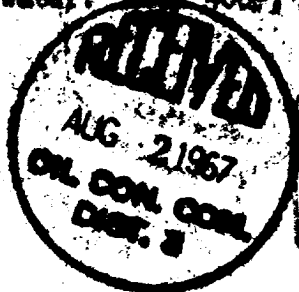

On 5-25-67 spudded well, drilling surface hole.

On 5-27-67 ran 4 joints 8 5/8", 24#, J-55 casing (122') set at ground level w/105 sacks cement circulated to surface. W.O.C. 11 days, tested w/600#/30 Min. O. K.

On 6-10-67 T.D. 3944', ran 124 joints 2 7/8", 6.4#, J-55 casing (3934') set at 3493 3944' w/130 sacks cement. W.O.C. until completion.

On 7-20-67 P.B.T.D. 3927', tested casing to 4000' O. K. Perf. Pictured Cliffs 3808-26', 3864-82' w/24 SPZ. Frac w/30,000 lb/20 sand, 30,340 gallons of water. Max. pr. 4000#, BDP 2500#, tr. pr. 3500-3800-4000#. I.R. 22.5 BPM. Dropped 1 set of 36 balls, flushed w/1500 gal. water. 1272 400#, 5 Min. 275#.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
