On 7-28-68 spudded well, drilled surface hole and ran 6 joints 32.30#, R-40 casing (188') set at 204' w/158 sacks of cement circulated to surface. W.O.C. 12 hours, tested w/600# 30 Min. O. K.

On 8-3-68 T.D. 3726', ran 116 joints 7", 20#, J-55 casing (3712') set at 3726' w/125 sacks of cement. W.O.C. 12 hours, tested w/800#/30 Min. O. K.

On 8-8-68 T.D. 7974', ran 253 joints 4 1/2", 11.6 & 10.5# J-55 casing (7962') set at 7974' w/400 sacks of cement. W.O.C. 18 hours.

On 8-10-68 P.B.T.D. 7951', tested casing to 4000# O. K. Spotted 300 gal. 7 1/2" BCL. Perf. 7892-98' w/4 SPF; 7908-24' w/1 SPF; 7924-28' w/2 SPF. Frac w/25,000# 40/60 sand, 28,380 gal. water. Max. pr. 4000#, BDP 1700#, tr. pr. 4000-4000-4000#. I.R. 23 BPM. Dropped 1 set of 24 balls, flushed w/5450 gal. water. ISIP 2200#, 30 Min. 800#. Set BP @ 7850' tested w/4000# O. K. Perf. 7702-10', 7720-30', 7828-38' w/24 SPF. Frac w/35,000# 40/60 sand, 35,280 gal. water. Max. pr. 4000#, BDP 2600#, tr. pr. 4000-4000-4000#. I.R. 25 BPM. Dropped 2 sets of 24 balls, flushed w/5250 gal. water. ISIP 2600#, 30 Min. 1500#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
