On 10-11-68 T.D. 8256'. Ran 255 joints 4 1/2", 10.5# & 11.6#, J-55 casing (8246') set at 8256' w/500 sacks of cement. W.O.C. 18 hours.

On 10-12-68 P.E.T.D. 8240', tested casing to 4000# O. K. Spotted 300 gal. 7 1/2% HCL. Perf. 7999-8007, 8017-35', 8084-94', 8128-38', 8172-78', 8203-13' w/1 24 3/4" frac w/80,000# 40/60 sand, 80,000 gal. water. Max. pr. 3700#, BDP 2700#, avg. tr. pr. 3650#. I.R. 41 BPM. Dropped 5 sets of 24 balls, flushed w/5544 gal. water. ISIP 1700#, 15 MinX 1200#, 30 Min. 900#.

Instructions
