13. Describe Proposed or Completed Operations

It is intended to recomplete the Mesaverde formation in the subject well as follows:

MIRU, ND WH, NU BOP and pull the production tubing. A CIBP will be set at approximately 6300' above the Dakota formation. The Mesaverde will be perforated and fracture stimulated in the following intervals: 4090-4884', 5066-5406' 5488-6033'. After stimulation flowback, the CIBP above the Dakota formation will be drilled out and tubing landed at approximately 7860'. The well will then be commingled. DHC-2274 has been received.
