On 11-11-68 spudded well, drilled surface hole and ran 7 joints 8 5/8", 24#, J-55 casing (218') set at 232' w/195 sacks of cement circulated to surface. W.O.C. 12 hours, tested w/600#/30 Min. O. K.

On 11-26-68 T.D. 7674', ran 238 joints 4 1/2", 11.6 & 10.5#, J-55 casing (7662') set at 7674'. Float collar set at 7663', second stage tool at 5646', third stage tool at 3315'. Cemented first stage w/280 sacks of cement, second stage w/165 sacks of cement, third stage w/150 sacks of cement. W.O.C. 18 hours.

On 11-28-68 P.B.T.D. 7630', tested casing to 4000# O. K. Spotted 300 gal. 7 1/2% HCL. Perf. 7364-80', 7468-82', 7498-7504', 7524-34' w/24 SPZ. Frac w/55,000# 40/60 sand, 55,000 gal. water. Max. pr. 4000#, BDP 1800#, avg. tr. pr. 3800#. I.R. 30.4 BPM. Dropped 3 sets of 24 balls, flushed w/5250 gal. water. ISIP 2100#, 30 Min. 1200#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
