13. Describe Proposed or Completed Operations

It is intended to recomplete the Mesaverde formation in the subject well as follows:

MIRU, ND WH, NU BOP and pull the production tubing. A CIBP will be set at approximately 5870' above the Dakota formation. The Mesaverde will be perforated and fracture stimulated in the following intervals: 4275-4825', 4885-5287', 5347-5835'. After stimulation flowback, the CIBP above the Dakota formation will be drilled out and tubing landed at approximately 7605'. The well will then be commingled. DHC-2286 has been received.
