5-12-73 TD 3504'. Ran 110 joints 2 7/8", 6.4#, J-55 production casing, 3493' set at 3504'. Baffle set at 3502'. Cemented with 253 cu.ft. cement. WOC 18 hours. Top of cement at 2200'.

6-22-73 PBTD 3502'. Tested casing, held 4000#. Perf'd 3420-50' with 30 shots. Frac'd with 32,000# 10/20 sand and 33,740 gallons treated water. No ball drops. Flushed with 840 gallons water.
