13. Describe Proposed or Completed Operations

It is intended to recomplete the Mesaverde formation in the subject well as follows:

MIRU, ND WH, NU BOP and pull the production tubing. A CIBP will be set at approximately 6800' above the Dakota formation. The Mesaverde will be perforated and fracture stimulated in the following intervals: 4902-5405', 5621-6045', 6163-6635'. After stimulation flowback, the CIBP above the Dakota formation will be drilled out and tubing landed at approximately 8503'. The well will then be commingled. A down-hole commingle application has been filed.


