- 4-8-74 T.D. 3526'. Ran 113 joints 2 7/8", 6.4#, J-55 production casing, 3515' set at 3526'. Baffle set at 3515'. Cemented with 235 cu.ft. cement. WOC 18 hours. Top of cement at 2500'.
- 5-2-74 Tested casing to 4000#-OK.
PBTD 3515'. Perf'd 3400-12', 3422-3446' with 24 shots per zone. Frac'd with 44,000# 10/20 sand and 43,974 gallons treated water. Dropped one set of 24 balls. Flushed with 840 gallons water.
