5- 7-74: Tested casing to 4000# - OK.
P.B.T.D. 3228'. Perf'd. 3108-3118, 3128-3138, and 3148-3160'
with 12 SPZ. Frac'd with 45,000# 10/20 sand and 44,720 gallons
treated water. Dropped 2 sets of 12 balls each. Flush with
780 gallons water.
