

Water for drilling and completion operations will be obtained from the following location: water hole located in Section 18, T-27-N, R-4-W.

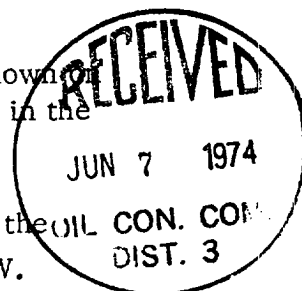
