

THE APPLICATION OF EL PASO NATURAL GAS
COMPANY FOR A DUAL COMPLETION.

ORDER NO. 40-2327

ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A El Paso Natural Gas Company made application to the New Mexico Oil Conservation Commission on April 13, 1977, for permission to dually complete its San Juan 27-4 Unit Well No. 123 located in Unit A of Section 7, Township 27 North, Range 4 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit production of gas from the Pictured Cliffs formation adjacent to the Tapacito-Pictured Cliffs Pool and from the Blanco-Mesaverde Pool.

Now, on this 14th day of April, 1977, the Secretary-Director finds:

(1) That application has been duly filed under the provisions of Rule 112-A of the Commission's Rules and Regulations;

(2) That satisfactory information has been provided that there are no other operators of offset acreage.

(3) That the proposed dual completion will not cause waste nor impair correlative rights; and

(4) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, El Paso Natural Gas Company, be and the same is hereby authorized to dually complete its San Juan 27-4 Unit Well No. 123 located in Unit A of Section 7, Township 27 North, Range 4 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit production of gas from the Pictured Cliffs formation adjacent to the Tapacito-Pictured Cliffs Pool and from the Blanco-Mesaverde Pool through the casing-tubing annulus and the tubing respectively.

PROVIDED HOWEVER, That applicant shall complete, operate, and produce said well in accordance with the provisions of Rule 112-A.

PROVIDED FURTHER, That applicant shall take packer-leakage tests upon completion and annually thereafter.

IT IS FURTHER ORDERED: That jurisdiction of this cause is hereby retained for the entry of such further orders as the Commission may deem necessary.
