We intend to replace tubing and clean out wellbore with air package to below bottom perforations.

T.O.H. and salvage 1" tubing set at 3582'.

T.I.H. with 2 3/8" tubing and mill to drill out packer set at 3549'.

Drill out packer, continue in hole with 2 3/8" tubing, clean out well bore to PBTD at 3680'.

T.O.H. with tubing and mill.

T.I.H. with 1 1/2" production string, land on doughnut at approximately 3580'.

Return well to sales line.

Estimated starting date, April 19, 1999.

No new surface will be disturbed, location area will be cleaned up when workover operations are completed.
