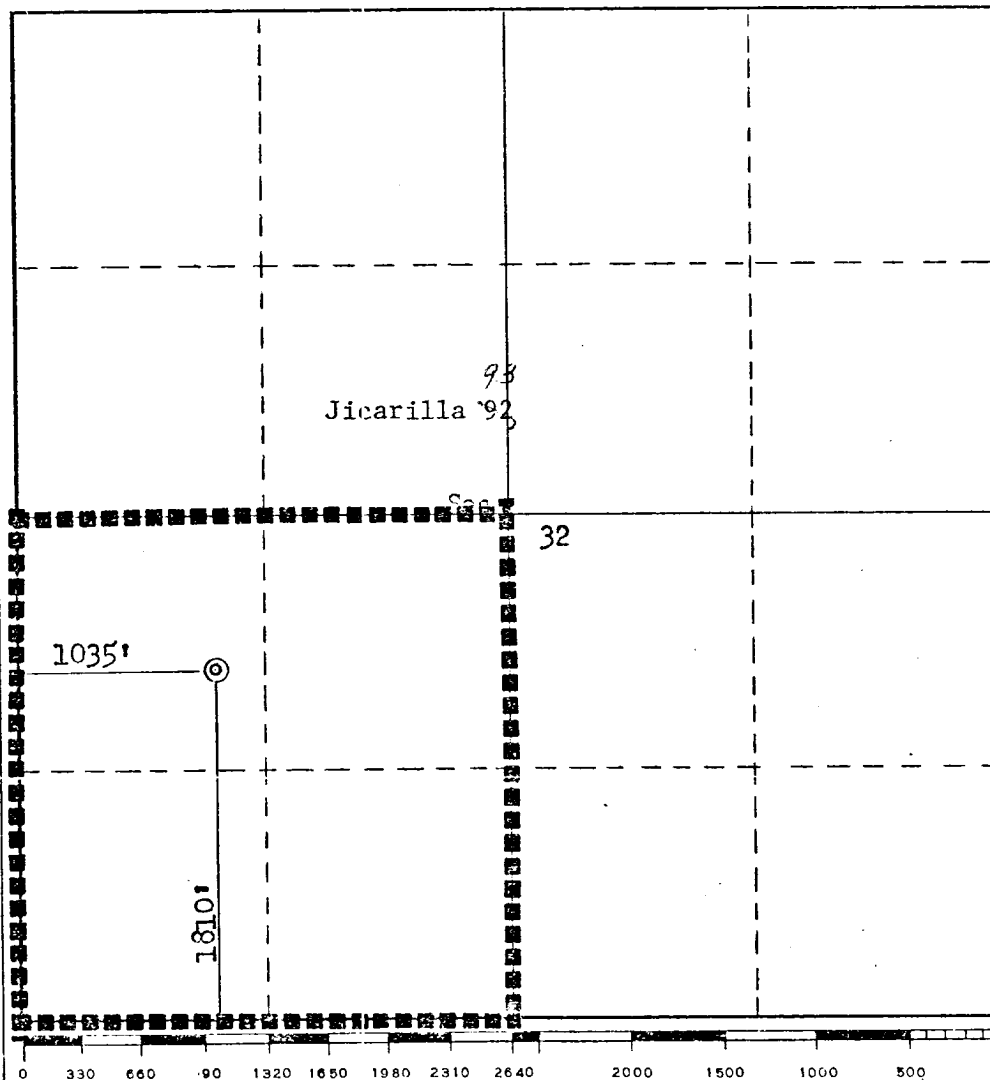

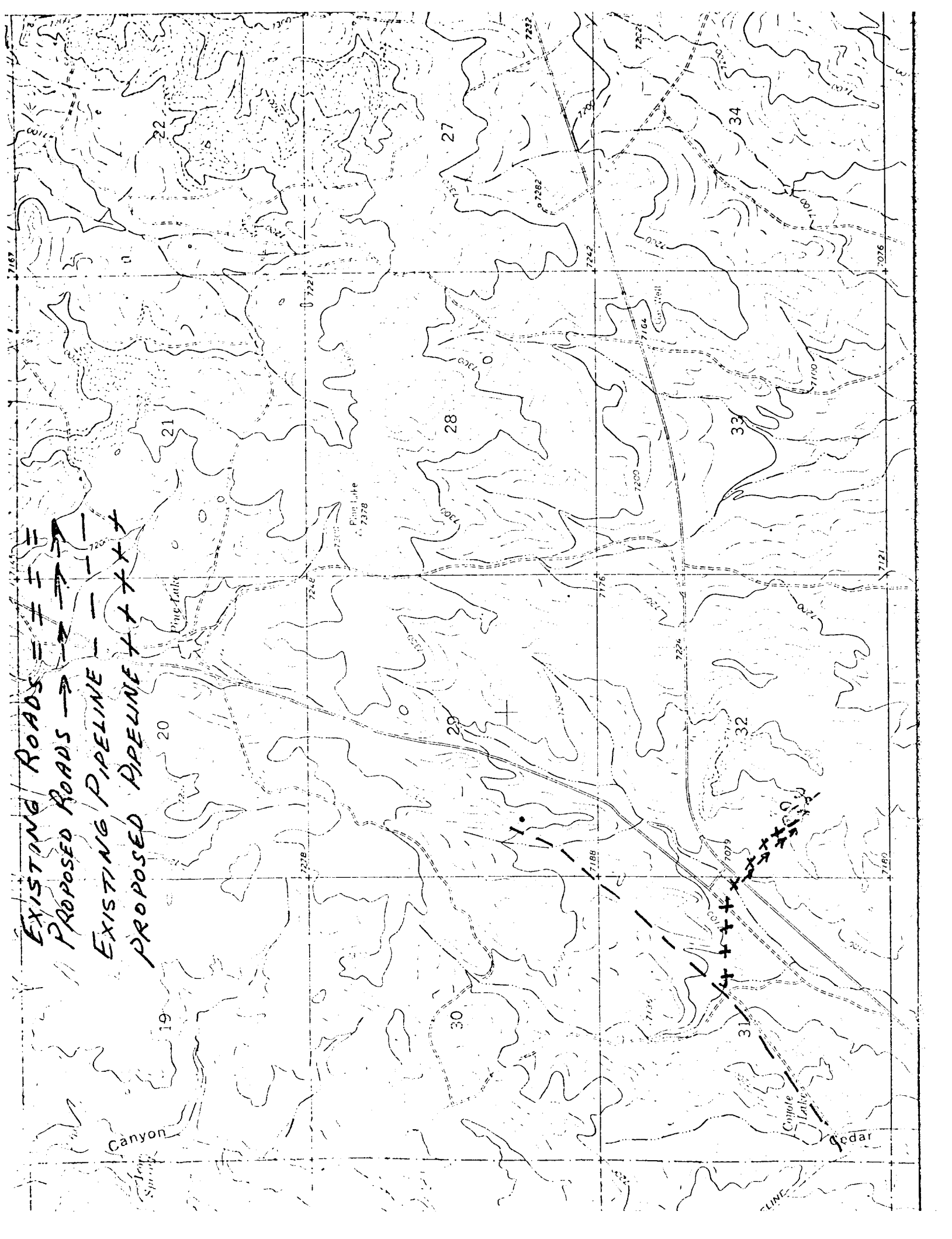

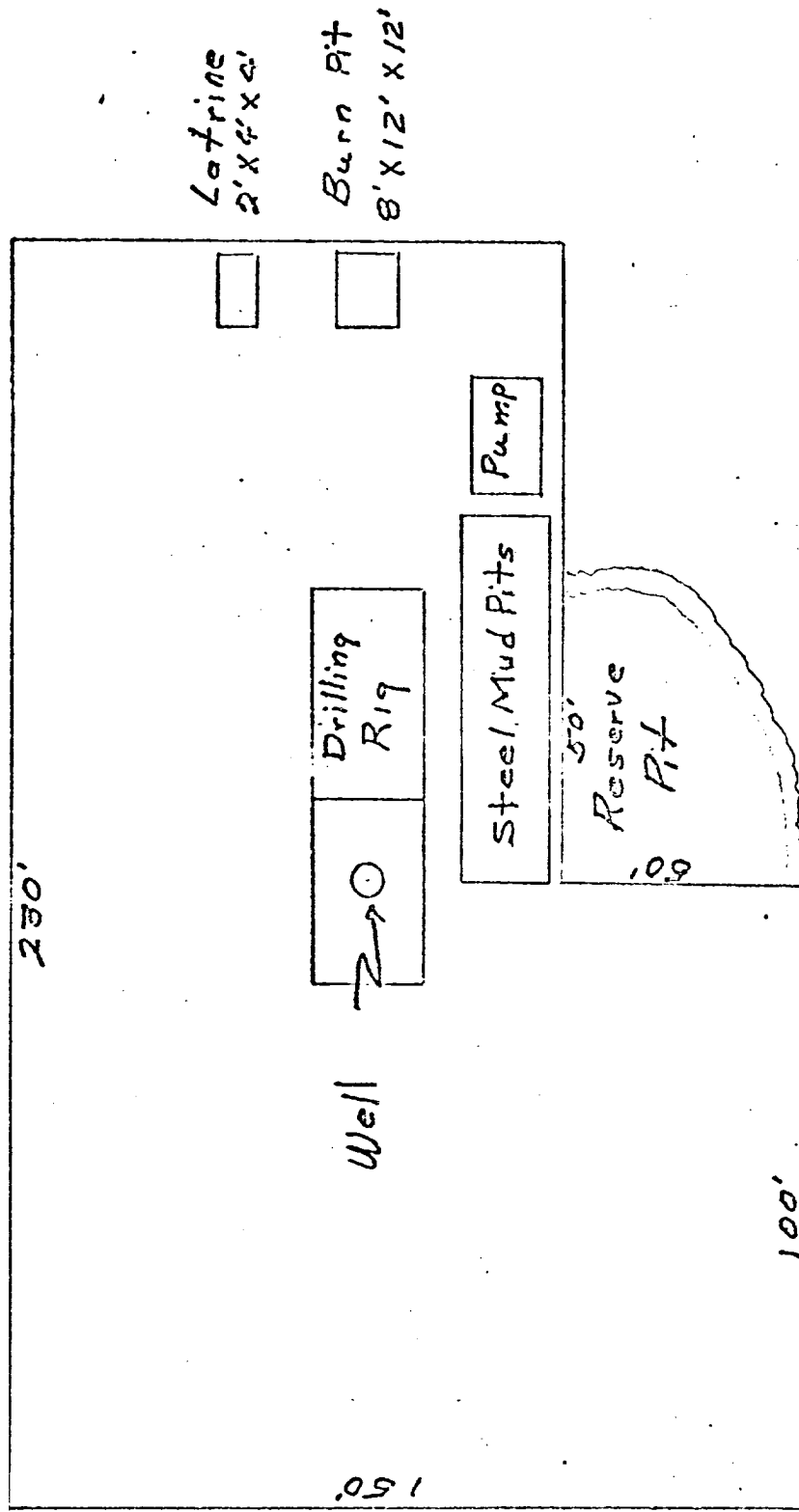


EXISTING ROADS = = =
