Gentlemen:

By Sundry Notice you advised that you would not drill the following two wells on the Palmer Joint Venture Area in Rio Arriba County, New Mexico:

Well No. 6A, 1530 feet from the north and 1460 feet from the west lines of section 16.

Well No. 8, 1500 feet from the north and 1850 feet from the west lines of section 21.

These wells are being replaced by wells permitted at other locations in these sections. Approval of Applications for Permit to Drill the above wells is rescinded this date. Rescinded applications are enclosed. Any construction of access road and well pads will have to be restored to the satisfaction of the Bureau of Indian Affairs.

If at some later date you decide to drill wells at these locations, it will be necessary to file new applications.
