Dear Mr. Stamets:

This is a request for administrative approval for an unorthodox gas well location in the Basin Dakota Pool.

It is intended to locate the El Paso Natural Gas Company's San Juan 27-5 Unit #108E at 530' from the North line and 90' from the West line of Section 15, T-27-N, R-5-W, Rio Arriba County, New Mexico.

Due to extremely rough terrain in the form of a mesa in the southwest corner of this section makes it impossible to build an orthodox location. Furthermore, an abandoned location at this spot could be utilized for this well, which would minimize the surface damage in this area.

El Paso Natural Gas Company operates all proration units offsetting the proposed unorthodox location.

Plats showing the proposed well location and the terrain in Section 15, along with an ownership plat, are attached.

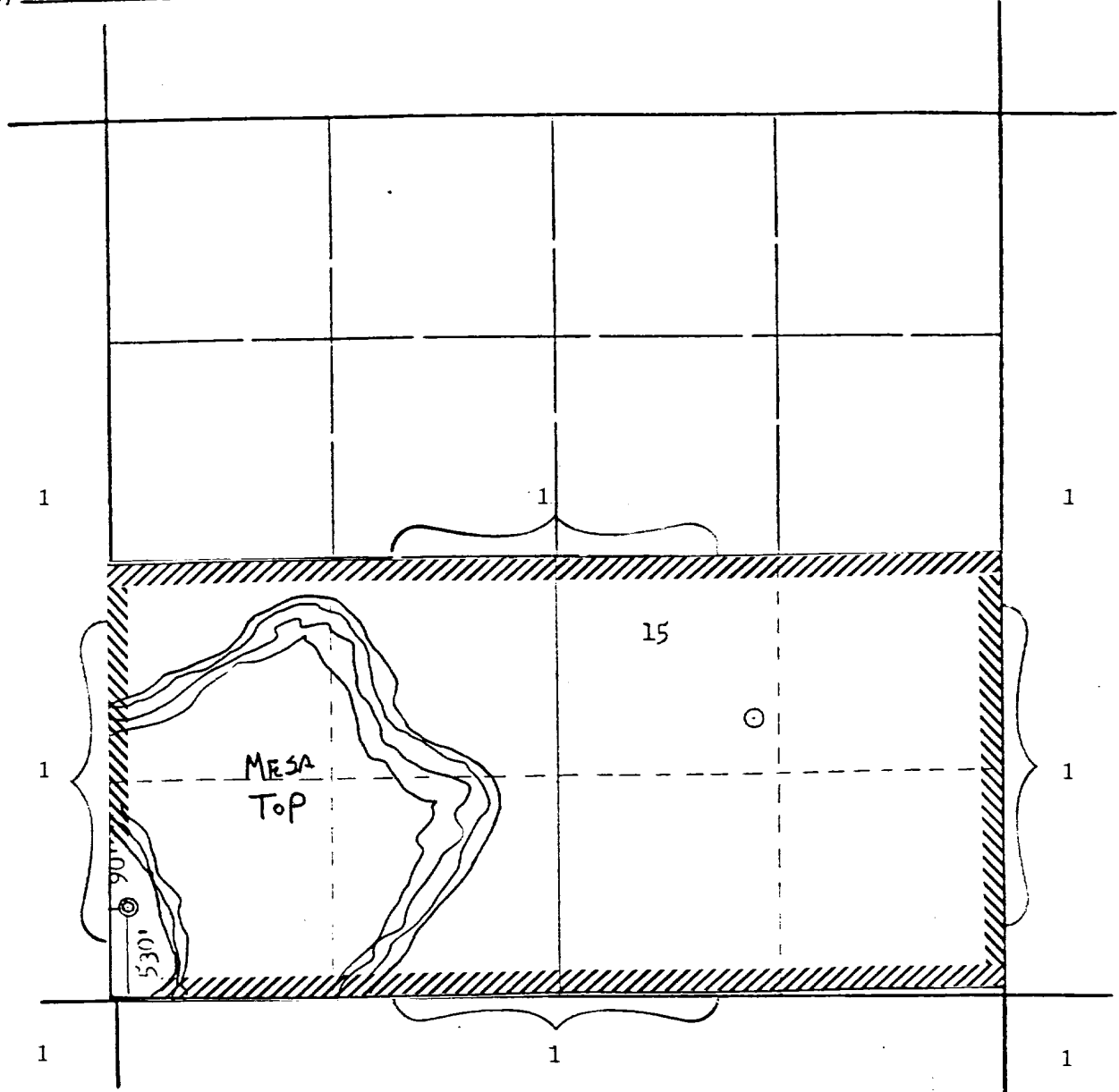

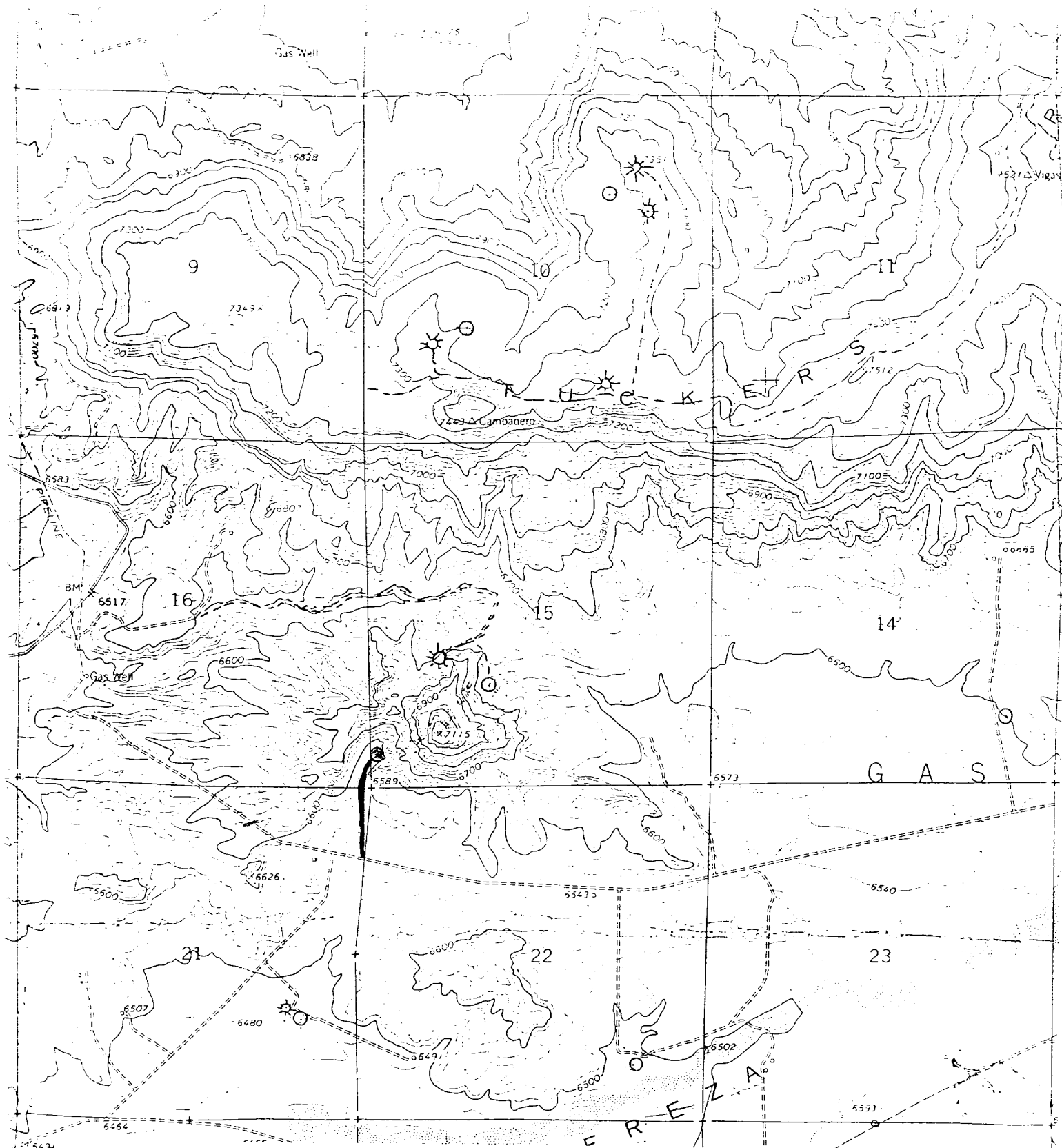
