2-1-98 Drill to intermediate TD @ 3225'. Circ hole clean. TOOH. TIH w/78 jts 7" 20# J-55 csg, set @ 3216'. Cmdt w/280 sx Class "B" neat cmt w/3% Econolite, 0.5 pps Flocele, 10 pps Gilsonite (806 cu.ft.).
