Cmtd w/300 sx Class "B" neat cmt w/3% Econolite, 10 pps Gilsonite, 0.5 pps Flocele (864 cu.ft.). Tailed w/90 sx Class "B" 50/50 poz w/2% gel, 10 pps Gilsonite, 0.5 Flocele, 2% calcium chloride (126 cu.ft.). Circ 8 bbl cmt to surface. WOC. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.
