Cmdt w/200 sx Class "B" neat cmt w/4% calcium chloride, 0.25 pps Flocele (236 cu ft). Circ 17 bbl cmt to surface. WOC. NU BOP. PT BOP & csg to 600 psi/30 min., OK. Drilling ahead.

5-11-98 Drill to intermediate TD @ 3695'. Circ hole clean. TOOH. TIH w/90 jts 7" 20# J-55 ST&C csg, set @ 3692'. Cmdt w/350 sx Class "B" neat cmt w/3% Econolite, 0.5 pps Flocele, 10 pps Gilsonite (1008 cu ft). Tailed w/90 sx Class "B" 50/50 poz w/2% gel, 2% calcium chloride, 0.5 pps Flocele, 10 pps Gilsonite (126 cu ft). Circ 38 bbl cmt to surface. WOC.
