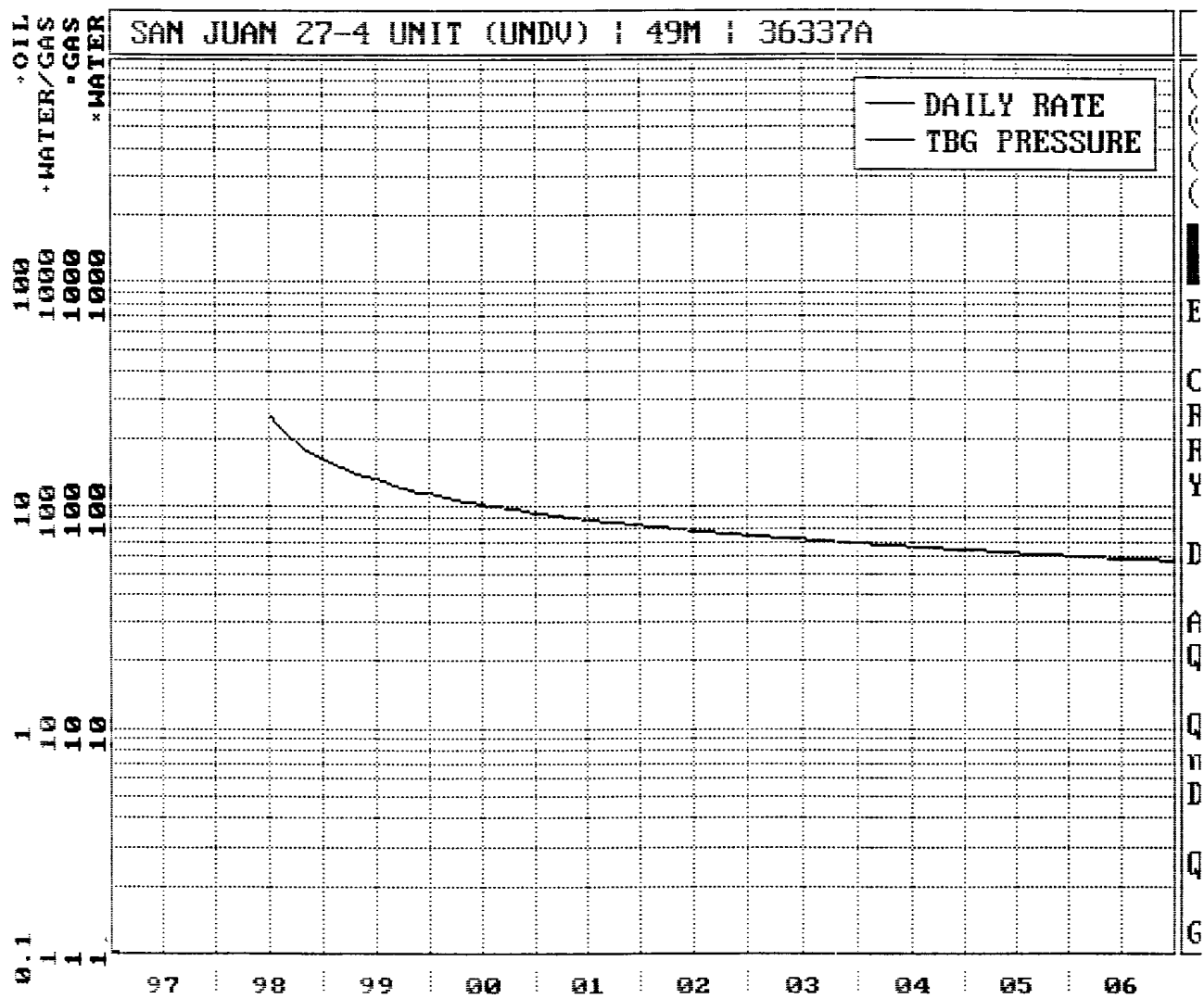

Expected Production Curve

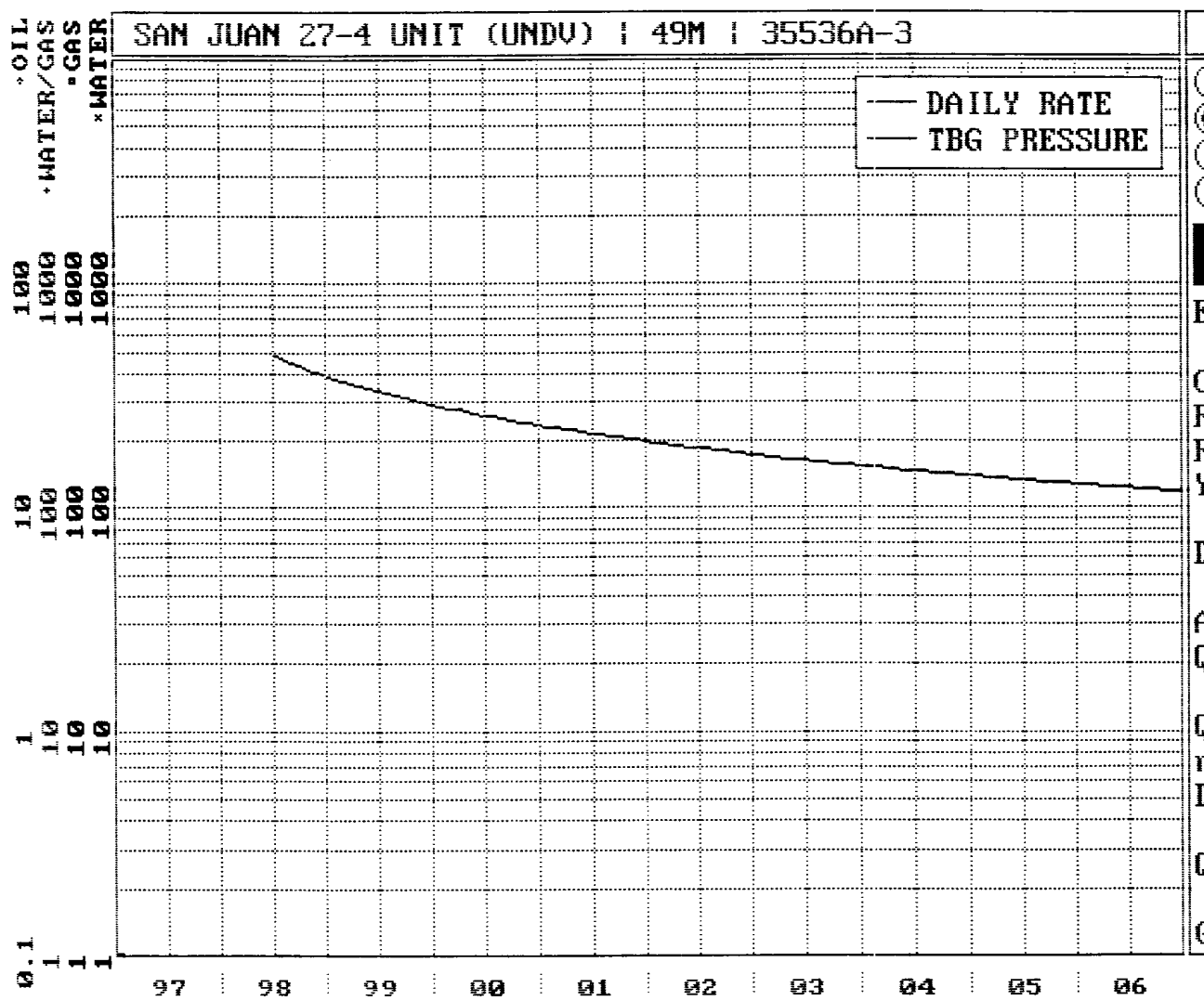

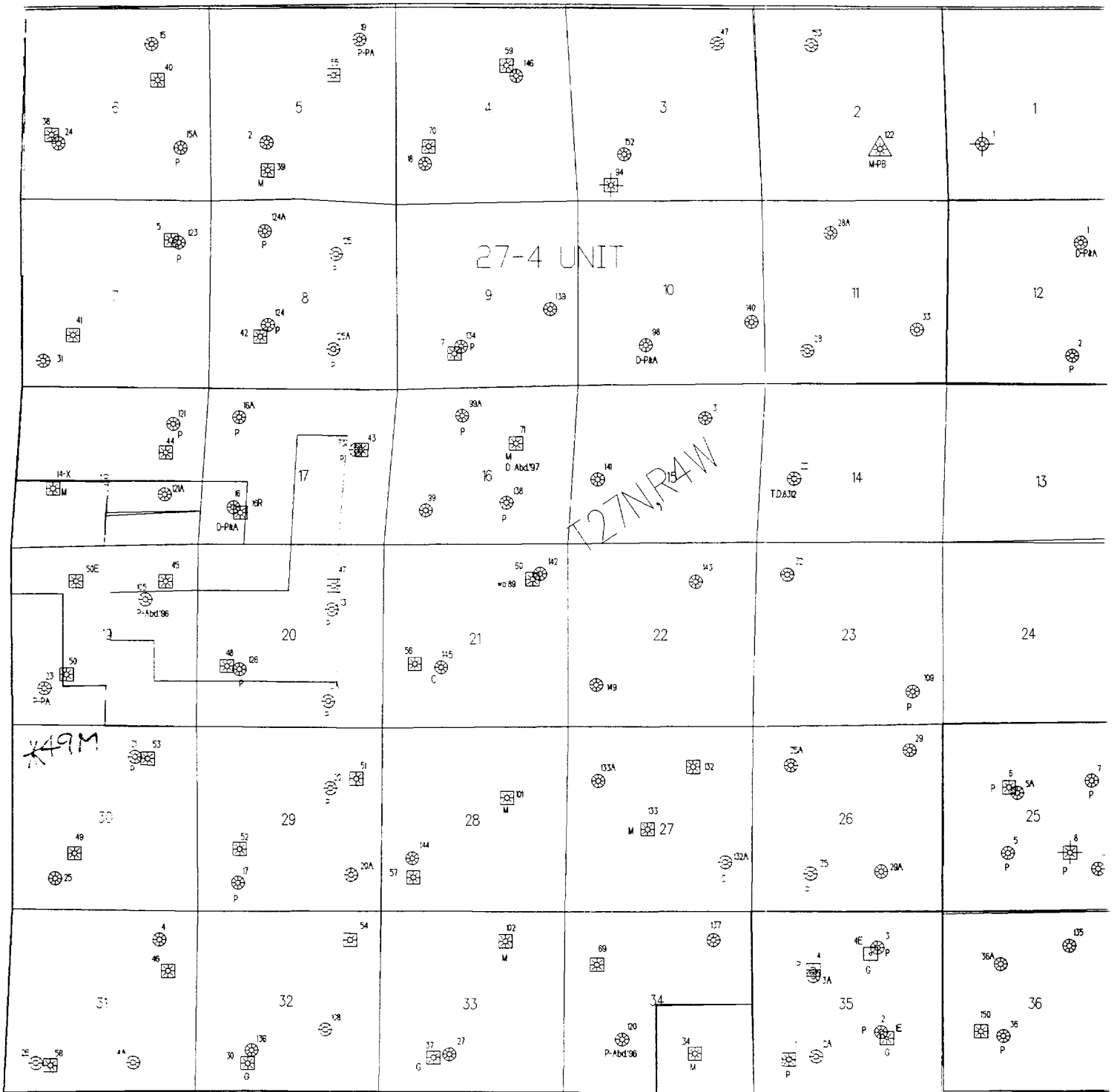

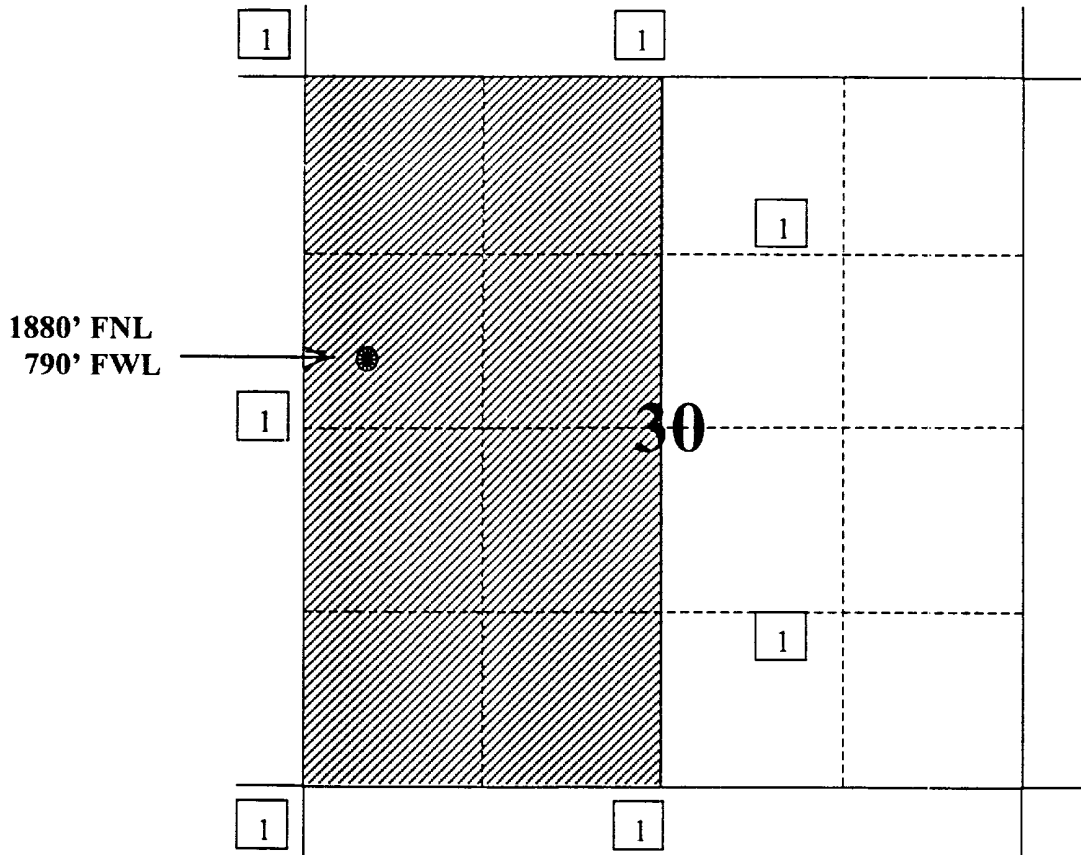
