4-10-99 TIH, blow well & CO. TOOH. TIH w/CIBP, set @ 3500'. TOOH. TIH. Load hole w/2% KCl wtr. PT CIBP to 1000 psi, OK. TOOH. TIH w/free point. Chemical cut 4 1/2" csg @ 3193'. SD for Sunday.

4-12-99 TOOH w/4 1/2" csg. TIH w/csg swedge. Work swedge over 4 1/2" lnr top @ 3193'. TOOH w/swedge. TIH w/3 7/8" mill. Mill out CIBP @ 3500'. Blow well & CO.

Please note: Well will produce as a Mesaverde/Dakota commingle under DHC-2063. Dakota was completed in October, 1998 before Forest Service restrictions were in place.
