Cmdt w/394 sx Class "B" neat cmt w/3% sodium metasilicate, 0.5 pps Flocele, 10 pps Gilsonite (1147 cu.ft.). Tailed w/90 sx Class "B" 50/50 poz w/2% gel, 2% calcium chloride, 0.5 pps Flocele, 10 pps Gilsonite (122 cu.ft.). Circ 48 bbl cmt to surface. WOC. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.
