8-31-99 Drill to intermediate TD @ 2926'. Circ hole clean. TOOH. TIH w/5 jts 7" 23# J-55 ST&C csg, 62 jts 7" 20# J-55 ST&C csg, set @ 2921'.

9-1-99 Pump 20 bbl wtr, 20 bbl chemical wash, 20 bbl wtr ahead. Cmted w/260 sx Class "B" neat cmt w/3% Econolite, 10 pps Gilsonite, 0.5 pps Flocele (757 cu.ft.). Tailed w/90 sx Class "B" 50/50 poz w/2% gel, 2% calcium chloride, 10 pps Gilsonite, 0.5 pps Flocele (126 cu.ft.). Circ 30 bbl cmt to surface. WOC. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

9-2-99 Drill to TD @ 5883'. Circ hole clean. TOOH.

9-3-99 TIH w/68 jts 4 1/2" 10.5# J-55 ST&C lnr, set @ 5880'. Top of lnr @ 2813'. Pump 10 bbl chemical wash, 2 bbl wtr ahead. Cmted w/280 sx Class "H" 50/50 poz w/5 pps Kolite, 2% gel, 0.25 pps Flocele, 0.5% fluid loss, 0.1% retardant (442 cu.ft.). Displace w/69.6 bbl wtr. Reverse circ 5 bbl cmt to surface. WOC. PT lnr to 3000 psi/15 min, OK. ND BOP. NU WH. RD. Rig released.
