10/27/00 - Ran 6 joints of 9-5/8" (36#, J-55) casing, set shoe at 287'. Cement with 175 sk Type III with 2% CaCl₂ with 0.25 pps Cello Flake. Displaced with 19 bbls water, returned 25 bbls to surface. Plug was not bumped.

10/30/00 - Ran 74 joints of 7" (20#, J-55) casing, set shoe at 3085'. Cement with 365 sk Prem Lite with 2% CaCl₂, 0.25 pps Cello Flake and 8% gel. Followed with tail cement of 80 sk Type III with 2% CaCl₂ and 0.25 pps Cello Flake. Displaced with 121 bbls water, returned to surface. Bumped plug with 1230# psi at 10:51 am. Floats held.

11/03/00 - Ran 171 joints of 4-1/2" (10.5#, J-55) casing, set shoe at 7246'. Cement with 525 sk Premium Lite High Strength with 0.25 pps Cello Flake, 0.2% CD-32, and 0.65% FL-32. Displaced with 113 bbls water, returned some water to surface. Bumped plug at 5:35 am with 1500# psi. Floats held.
