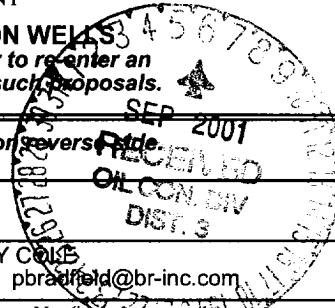

Cmt w/428 sx Class "B" 50/50 poz w/3% gel, 4% calcium chloride (569 cu.ft.). Tailed w/90 sx Class "B" 50/50 poz w/2% gel, 5 pps Gilsonite, 2% calcium chloride, 0.25 pps Flocele (120 cu.ft.). Displace w/138 bbl wtr. Circ 50 bbl cmt to surface. WOC.
- PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.
- 8-21-01 Drill to TD @ 6270'. Circ hole clean. TIH w/70 jts 4 1/2" 10.5# J-55 ST&C lnr, set @ 6270'. Top of lnr @ 3298'. Pump 10 bbl chemical wash, 2 bbl wtr ahead. Cmt w/284 sx Class "B" 50/50 poz w/3% gel, 0.25 pps Celloflake, 5 pps Gilsonite, 5% fluid loss, 0.2% retardant (418 cu.ft.). Reverse circ 13 bbl cmt to surface. WOC. PT lnr to 3000 psi/15 min, OK.
