11/23/00 - Ran 6 joints of 7" (20# J-55) casing, set shoe at 268', hole size is 8-3/4". Cement with 75 sx Type III. Displaced with 9.2 bbls freshwater, returned 6 bbls to surface. Bumped plug at 3:00 am with 70# psi. Floats held.

11/26/00 - Ran 82 joints of 4-1/2" (10.5# J-55) casing, set shoe at 3450', hole size is 6-1/4". Cement with 267 sx Pox Type III with 6% Gel, 10 pps CSE, 2% CD-32, 0.25 pps Cello Flake, and 0.65% FL-32. Displaced with 54 bbls of 2% KCl, returned 1 bbl to surface. Bumped plug at 1:30 pm with 1,700# psi, floats held.
