Cemented with 550 sx 65/35 "B" Poz, 6% gel, 10#/sx gilsonite, 2% CaCl2 followed with 100 sx 50/50 Poz, 2% CaCl2, and 1/4#/sk flocele (1213 cu.ft.) Plug down at 11:00 am 01/01/01. Did not circulate cement. RD Halliburton. Set slips & NU BOP. RU wireline & RIH w/temp. survey. TOC @ 1600'. RD wireline. Test casing to 1200# - OK.
