Cmdt w/250 sx Class "H" neat cmt w/2% calcium chloride, 0.5 pps Flocele (295 cu.ft.). Displace w/14 bbl wtr. Circ 14.5 bbl cmt to surface. WOC. Cmt fell back 40' after 30 minutes.
- 11-20-00 Pump 75 sx Class "H" neat cmt w/2% calcium chloride, 0.3% fluid loss down backside (89 cu.ft.). NU BOP. PT BOP & csg to 600 psi/30 min, OK. Drilling ahead.
