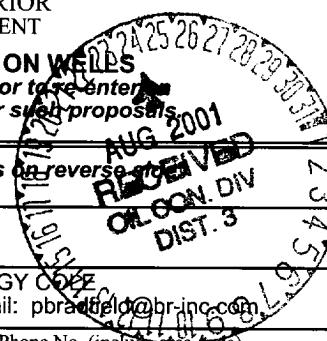

Cmt d w/476 sx Class "B" 50/50 poz w/3% gel, 4% calcium chloride (633 cu.ft.). Tailed w/90 sx Class "B" 50/50 poz w/2% gel, 5 pps Gilsonite, 2% calcium chloride, 0.25 pps Flocele (120 cu.ft.). Displace w/152 bbl wtr. Circ 130 bbl cmt to surface. WOC.

PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

7-28-01 Drill to TD @ 6585'.

7-29-01 Circ hole clean. TOOH. TIH w/68 jts 4 1/2" 10.5# J-55 ST&C lnr, set @ 6585'. Top of lnr @ 3656'. Pump 10 bbl chemical wash, 2 bbl wtr ahead. Cmt d w/276 sx Class "B" 50/50 poz w/5 pps Gilsonite, 3% gel, 0.2% reducer, 0.25 pps Flocele, 1% fluid loss, 0.1% retardant (406 cu.ft.). Reverse circ 2 bbl cmt to surface. WOC. PT lnr to 3000 psi/15 min, OK. ND BOP. NU WH. RD. Rig released.
