Pump 464 sacks Premium Lite FM w/3% calcium chloride, 0.25 pps Celloflake, 5 pps Gilsonite, 0.5% fluid loss, 10% gel, 0.4% sodium metasilicate, 2 pps Pheno seal. Tailed w/63 sx Premium Lite High Strength FM w/1% calcium chloride, 0.25 pps Celloflake, 0.6% fluid loss, 2 pps Phenoseal.

Verbal approval to change cement slurry from Steve Mason, BLM on 6-25-01.
