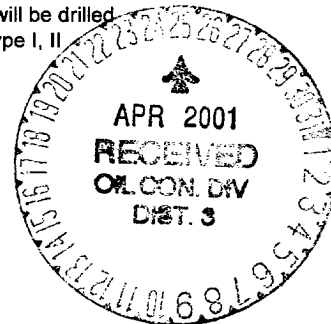

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. It is intended to alter the approved surface casing depth and cement of the subject well. A 9 7/8" hole will be drilled to 120'. 7" 20# J-55 casing will be run to 120'. It will be cemented with 27 sacks Class A, B Portland Type I, II cement (32 cu.ft. of slurry, bringing cement to surface through a 3/4" line).
