Conoco Inc. proposes to make changes to the surface casing on the above mentioned well. The Wellbore changes proposed are as follows:

Raise Permitted Surface Casing Depth to 200' as per NMOCD Minimum Required Depth for wells in San Juan Basin, NM with intermediate casing set from 300' to 500';
For Surface Cement change to 13.5 ppg Type III Cement + 2% bwoc Calcium Chloride + 0.25 lbs/sack
Cello Flake + 3% bwoc Bentonite + 80.7% Fresh Water.
Test Surface Casing to 500 psig.
