2. Furnish copies of all logs.

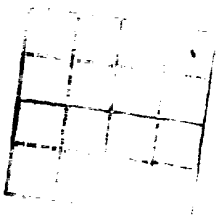

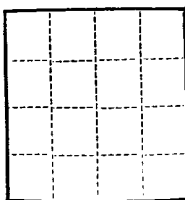
