New Mexico

Sunray Mid-Continent Oil Company requests the commission to grant an
exception to Commission Order #R-1427 for the Sunray Mid-Continent
#1 Hickman located 330 FSL and 330 FWL, Section 32, Township 26 North,
Range 12 West, San Juan County, New Mexico.

The Hickman #1 is a very weak stripper well which produces only 300 barrels
of oil per month and some 155 MCF of gas. The well is pumped by a gas
engine which uses 126 MCF of the produced gas. This leaves a net figure of
only 39 MCF of gas to be sold each month which makes it uneconomical for
the gas purchaser in the area to connect the well. Also sometime in the
near future it is planned to take this well into the Central Dist Unit
and use it as a gas injection well. This, of course, will eliminate any
flaring of gas from the subject well.
