

Gentlemen:



Chevron U.S.A. Inc., as operator of the West Bisti Lower Gallup Sand Unit, requests a two-year extension be granted from this day forward for Well #153, a temporarily abandoned water injection well. This two-year extension is requested so as to facilitate the completion of a waterflood Field Performance Evaluation and Enhanced Oil Recovery Feasibility Study.

Well #153 has been temporarily abandoned since March, 1984 and presently has an approved temporary abandonment status, which expires on 5/1/87. This well is located on a federal lease, however, since it was an injection well approval of an extension is sought through the State of New Mexico, Oil Conservation Division.

Chevron has likewise requested a two-year extension be granted, by the BLM, for eighteen other temporarily abandoned wells in the West Bisti Unit all of which are located on Federal or Indian Leases (see attached correspondence).

In view of the fact that Chevron is currently assembling, reviewing and verifying for study all available individual well and unit data, the premature plugging of temporarily abandoned wells prior to the completion of our study could quite possibly cause a loss of economic incentive. Chevron proposes to work diligently to evaluate the economics potential of this well with the intent to take appropriate action as our study reveals.

Gentlemen:

Chevron U.S.A., Inc., by means of merger with Gulf Oil Corp. dated July 1, 1985, has been named as successor Operator for the referenced unit. Chevron, as operator, hereby requests a two-year extension be granted, from this day forward, for the nineteen temporarily abandoned wells listed below so as to facilitate the completion of a Waterflood Field Performance Evaluation and Enhanced Oil Recovery Feasibility Study.

In as much as Chevron is currently in the process of assembling reviewing and verifying for study all available data (i.e. production histories, well files, core data, BHP surveys, injection patterns, etc.) the premature permanent plugging of temporarily abandoned wells prior to the completion of our study could very possibly cause a loss of economic incentive. All nineteen temporarily abandoned wells have received last extension dates of January 1, 1987 which, in our estimate, is insufficient time for a prudent Waterflood Field Performance Review. However, Chevron realizes the inordinate length of time many of these wells have been subject to a temporary abandonment status and understands the BLM's desire to force some action. Therefore, we vow to work steadily in an effort to evaluate the economic potential of each TA'd well with the intent to take appropriate action as our study reveals.
