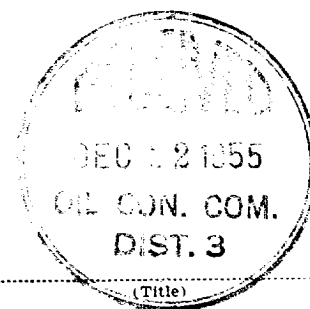

TD 2200'. Flowing 74 MCF/day. Sand-oil treated from 2128' to 2200' with 17,700 gallons diesel oil and 30,000* sand, flushed with 2,300 gallons diesel oil. Breakdown pressure 1050*, treating pressure 900*, injection rate 31.6 barrels per minute. After 8 hours flowing 1,830 MCF/day.
