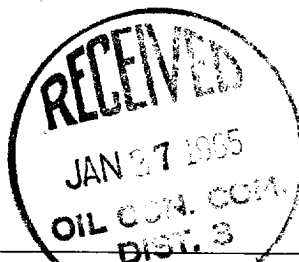

Spudded 8:00 PM 1-9-65.

Drilled 17-1/4" hole to 96' and cemented 84' of 13-3/8" casing at 96' with 50 sacks of regular cement with 8% gel added followed by 50 sacks of regular cement with 2% calcium chloride added. Cement circulated. Drilled 11" hole to 188' and water circulated behind conductor casing. Recemented 13-3/8" casing with 100 sacks of regular cement with 4% calcium chloride added. Cement circulated.

Drilled 12-1/4" hole to 1526' and cemented 1513' of 8-5/8" casing at 1526' with 650 sacks of regular cement followed by 50 sacks of regular cement with 2% calcium chloride added. Cement circulated. Tested casing with 800 PSI for 30 minutes. Casing tested okay.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
