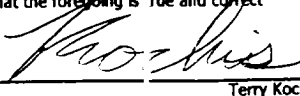
13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. Plugged well as follows:

- 1) Perforated top of Mesaverde @ 2,060', set retainer @ 1,992'. Pressure test casing, not holding pressure. Unable to pump under retainer 1,000 psi. Spotted 10 sx (11.8 cu ft) Class "B" cement from 1,906'-1,992'.
- 2) Perforated top of Pictured Cliffs @ 1,320', set retainer @ 1,265'. Pressure test casing, not holding pressure. Pump under retainer 100 sx Class "B" cement w/4% gel (155 cu ft), spotted 36 sx (55.8 cu ft) Class "B" cement w/4% gel from 858'-1,265'.
- 3) Perforated below surface casing @ 280'. Est. circulation out bradenhead. Fill casing & surface pipe with 85 sx (131.75 cu ft) Class "B" cement w/4% gel.
- 4) Set dry hole marker. Job complete 03/20/01.
