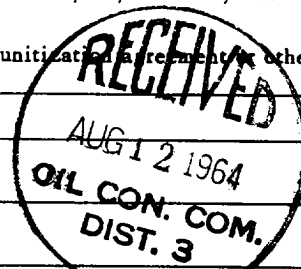

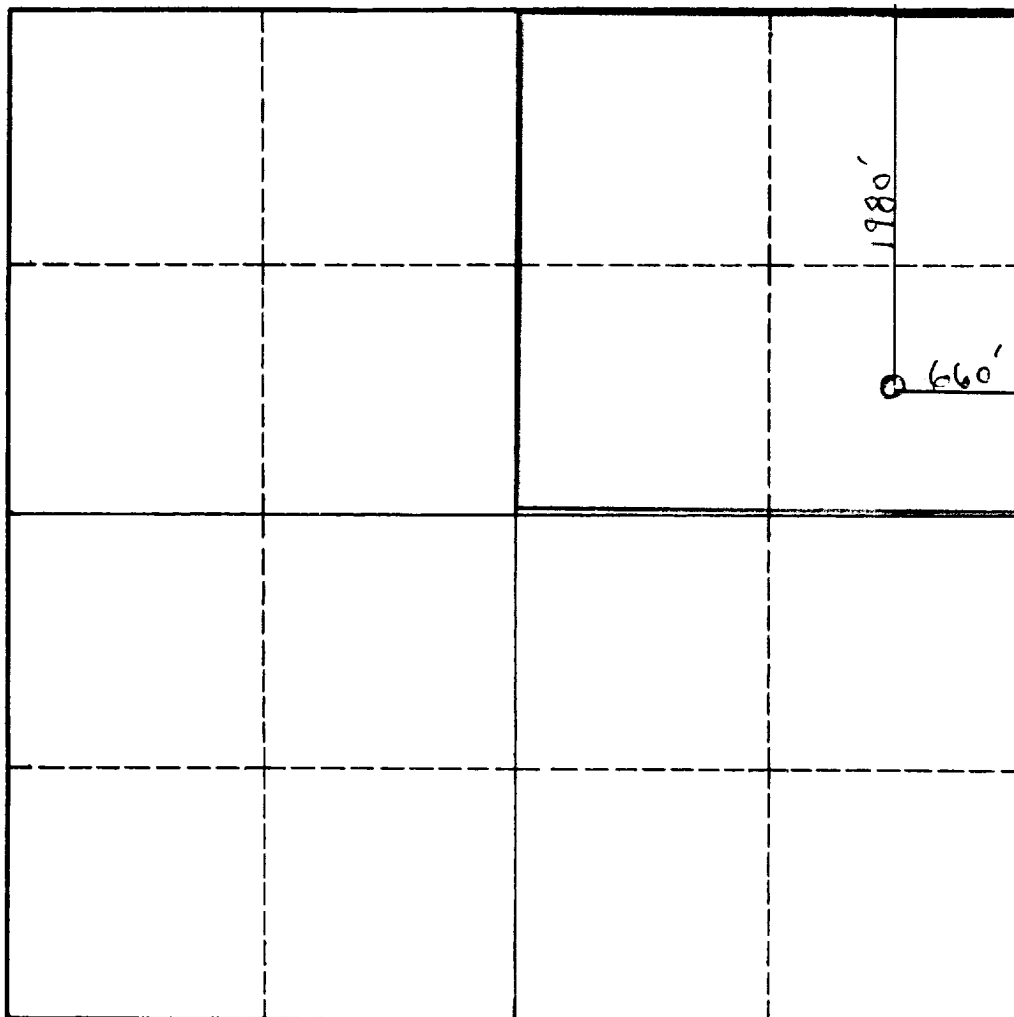

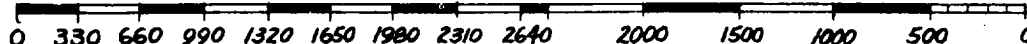

## **INSTRUCTIONS FOR COMPLETION OF FORM C-128**

1. Operator shall furnish and certify to the information called for in Section A.
2. Operator shall outline the dedicated acreage for *both* oil and gas wells on the plat in Section B.
