1. Tag Gallup plug ±4843'.
2. Found top hole in casing 2806-2836' with tubing and packer.
3. Perforate Mesa Verde at 2958'.
4. Spot 77 cu. ft. Class B cement with 2% CaCl₂ at 2963'. Displace cement to ±2758'. Tag cement ±2758'. Mesa Verde plug 2758' - 2963'.
5. Perforate Pictured Cliffs at 1542'.
6. Spot 219 cu. ft. Class B cement at 1559'. Displace cement to 1188'. Tag cement at 1200'. Pictured Cliffs - Fruitland plug 1200' - 1559'.
7. Perforate below surface casing at 314'.
8. Cement through 5 1/2" out bradenhead to surface with 156 cu. ft. Class B cement with 4% gel.
