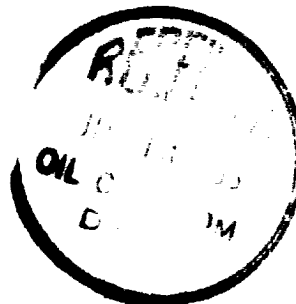

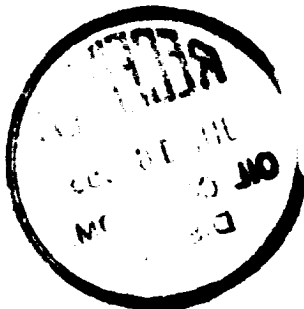

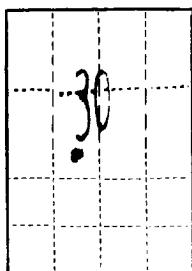

Will set 5 1/2", 15.5# Csg to T. D. and perforate for production.

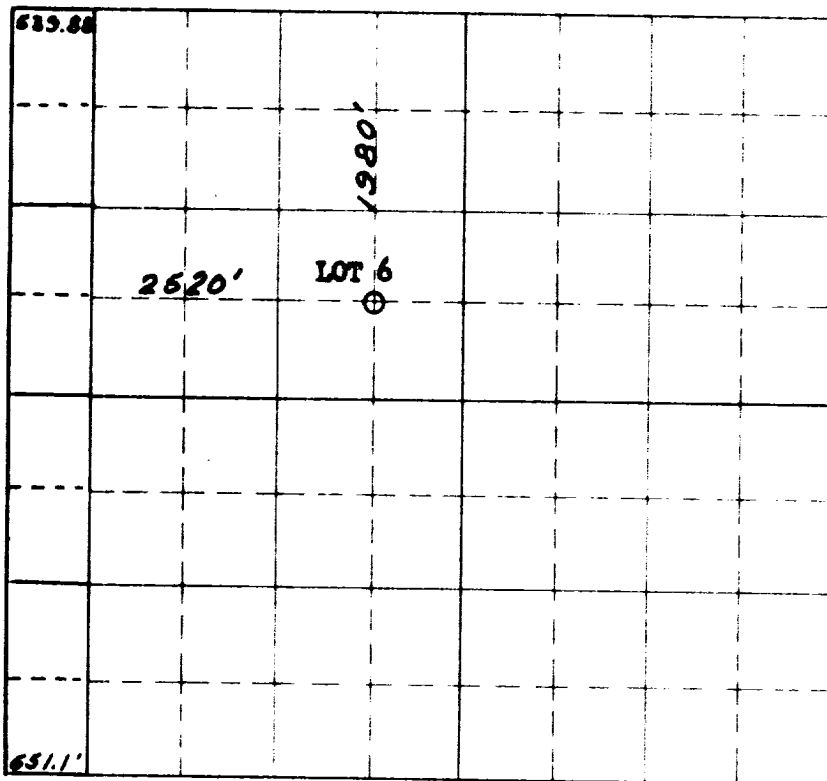
