250' of 10-3/4" OD casing, 32.75# EW H-40, cemented with 250 sacks cement, to be circulated.

5500' of 5-1/2" OD casing, 14# SS J-55, cemented with 250 sacks cement.

The designated drilling unit is the SE 1/4-SW 1/4 of Section 20-26N-13W, San Juan County, New Mexico.

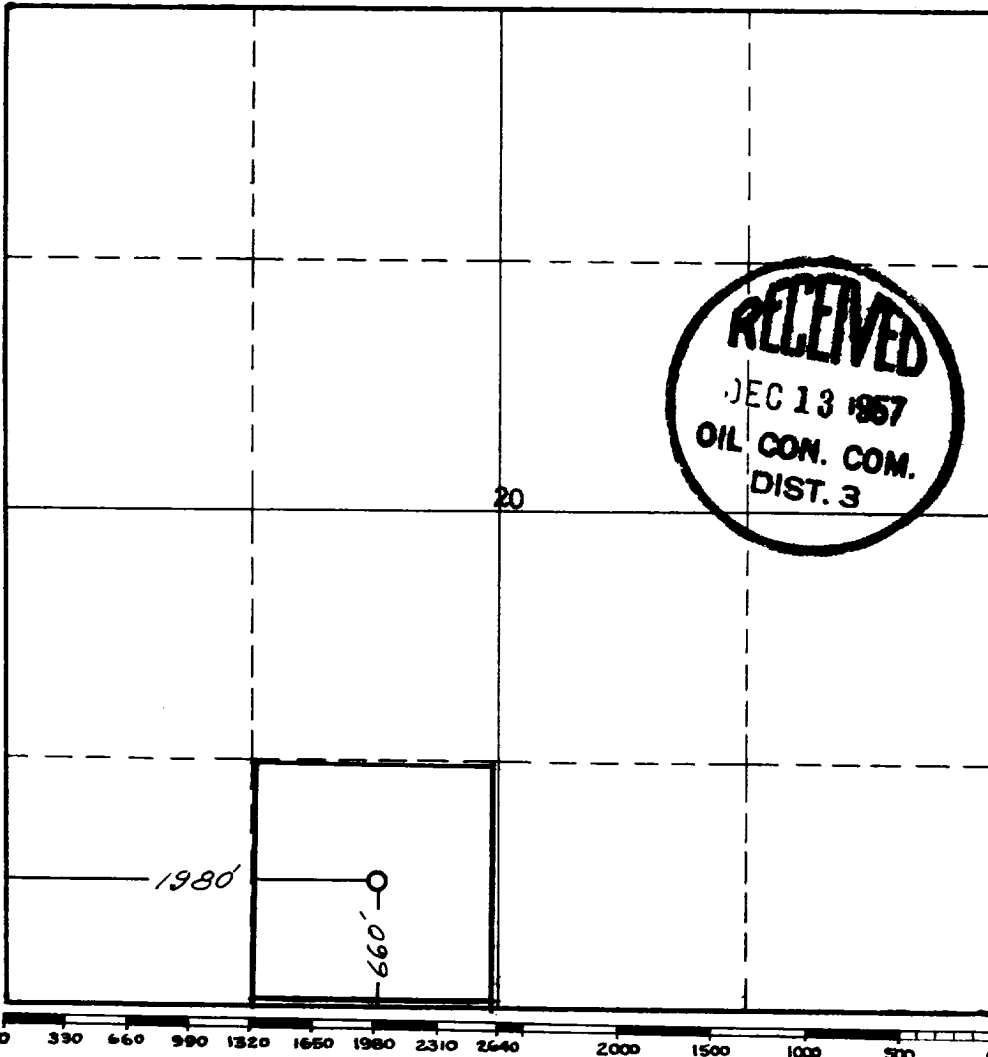
