Due to the uneconomic status of the Newson No. 10, it is therefore intended to plug and abandon the subject well as follows:

- 1. Rig up and pull 1" tubing.**
- 2. Pump class "A" cement plug from T.D. 2262 ft. to 2100 ft.**
- 3. Perforate four (4) squeeze holes at 1600 ft. in 5-1/2" casing and squeeze with class "A" cement, 75 ft. inside and 75 ft. outside of pipe.**
- 4. Pump 40 ft. cement plug in surface at 91 ft. to 51 ft.**
- 5. Put 10 ft. plug at surface and set Dry hole marker.**
- 6. Restore location.**

Instructions
