This is a request for administrative approval for a non-standard gas well location in the Basin Fruitland Pool.

Meridian Oil intends to plugback and recomplete the Huerfano Unit #23 well from the Pictured Cliffs pool to the Basin Fruitland Coal Pool. The current location of this well is 1650'FSL, 990'FEL, Section 19, T-26-N, R-09-W, San Juan, New Mexico. The well is considered non-standard due to the NE-SW dedicated pattern established for the Basin Fruitland Coal Pool. To comply with the New Mexico Oil Conservation Division rules, Meridian is submitting the following for your approval of this non-standard location:

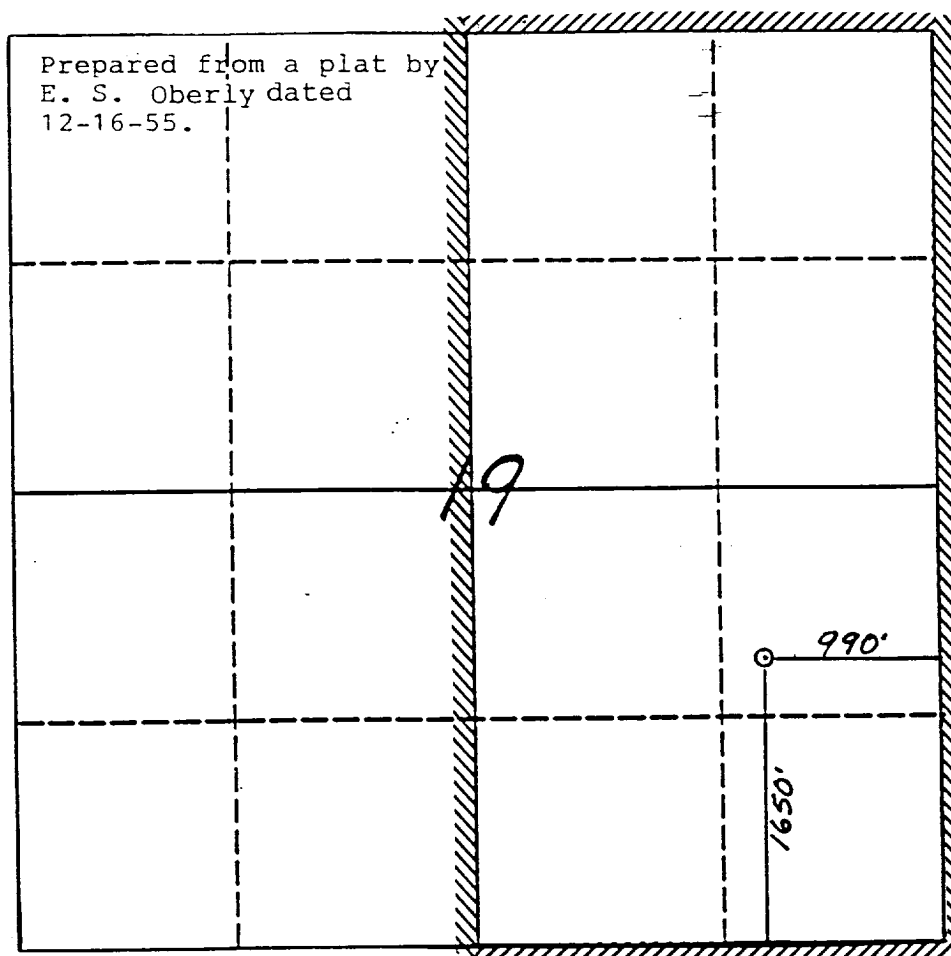

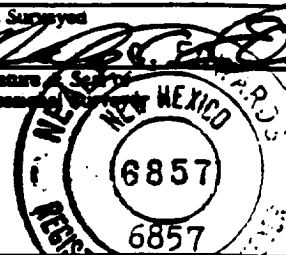

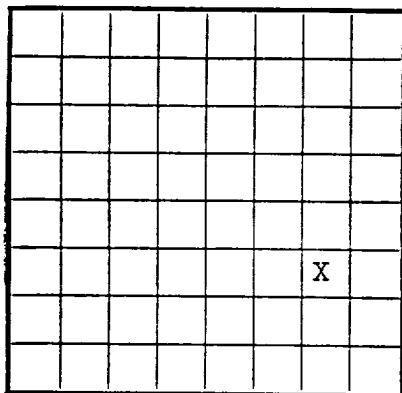
