3. Perforate 5½" casing @ 2192'. Spot 61 cu. ft. class "B" cement @ 2193'. Displace cement to 1942'. Mesa Verde plug 1942' - 2192'.
4. Perforate 5½" casing @ 1460'. Spot 171 cu. ft. class "B" cement w/4% gel @ 1467'. Displace cement to 963'. Pictured Cliffs - Fruitland plug 963' - 1460'.
5. Perforate 5½" casing @ 297'. Est. circulation. Cement to surface with 155 cu. ft. class "B" cement with 4% gel (5½" casing and surface annulus full of cement). Ojo Alamo - surface plug 0' - 297'.
